Because none of the fees under ISC's authority are set by act, regulation or fees notice, this report only presents fees that are set by contract. The amount in this report represents a residual amount from an expired contract.

About this report

This report, which is tabled under section 20 of the *Service Fees Act*ⁱ, the *Low-Materiality Fees Regulations*ⁱⁱ, and subsection 4.2.8 of the Treasury Board *Directive on Charging and Special Financial Authorities*ⁱⁱⁱ, contains information about the fees Indigenous Services Canada had the authority to set in fiscal year 2022–23.

The report covers fees that are subject to the *Service Fees Act*.

For reporting purposes, fees are categorized by fee-setting mechanism. There are three mechanisms:

1. **Act, regulation or fees notice**
The authority to set these fees is delegated to a department, minister or Governor in Council pursuant to an act of Parliament.
2. **Contract**
Ministers have the authority to enter into contracts, which are usually negotiated between the minister and an individual or organization, and which cover fees and other terms and conditions. In some cases, that authority may also be provided by an act of Parliament.
3. **Market rate or auction**
The authority to set these fees is pursuant to an act of Parliament or a regulation, and the minister, department or Governor in Council has no control over the fee amount.

No fees under Indigenous Services Canada’s authority are set by act, regulation or fees notice. This report therefore only covers fees set by contract. It provides total revenue and costs only.

Although the fees that Indigenous Services Canada charges under the *Access to Information Act* were subject to the *Service Fees Act*, they are not included in this report. Information on Indigenous Service Canada’s access to information fees for 2022–23 is in our *Annual Report to Parliament on the administration of the Access to Information Act*^{iv}.

Remissions

In 2022–23, Indigenous Services Canada was not subject to the requirements in section 7 of the *Service Fees Act* and had no authority to remit, so this report does not include remission amounts.

Overall totals, by fee-setting mechanism

The following table presents the total revenue, cost and remissions for all fees Indigenous Services Canada had the authority to set in 2022–23, by fee-setting mechanism.
